1. A bulletin with updates on the M27 Smart Motorway Programme has been shared with Councillors.

2. Email received from a local resident of Telegraph Road regarding lack of compliance with the No Waiting Traffic Cones that are put out on event days at the Ageas Bowl. The resident also wanted to report a large pothole around the drain outside 54 Telegraph Road. The Parish Office have reported the traffic once noncompliance to Eastleigh Borough Council and have reported the pothole to Hampshire County Council.

Councillors have reported issues in getting Hampshire County Council to engage in conversation around match day parking issues and have therefore asked the Parish Office to send a letter to Hampshire County Council imploring them to interact with us so these issues can be discussed. They will also invite Hampshire County Council to the Ageas Bowl Liaison Panel Meeting later this year.
