- The Clerk reported that the car park lines have been repainted at a cost of £3,298. This was slightly higher than expected but is still a saving on the full cost.

 The Hampshire Association of Local Councils (H.A.L.C.) membership is due for renewal on 10th May 2023 at a cost of £1,781.45.

Councillors confirmed they are happy to renew this membership.

- West End Local History Society (W.E.L.H.S.) have completed archiving the historical Parish documents, the earliest is dated 1872. There is an archive catalogue available to view at the Parish office.

Councillors found this very interesting and thanked W.E.L.H.S. for their work. It was questioned if the documents would be digitised but some are bigger than A3 and the volunteers may not have the facilities to action this.

The Parish Clerk reported that, with the changes that are now in place with the staffing set ups and timings, significant future savings will be made.

013/23/PR <u>IT REVIEW</u>

A quote has been obtained from QIC Systems Ltd. as an alternative to our current IT provider, Absolute. They can offer a similar proposition to our current provider, however, Absolute, are slightly more cost effective.

The Clerk explained that the service quality has dropped with the current supplier. However, they have been used to set up new laptops and resolve a few issues.

A discussion was held, and Councillors agreed that it would be beneficial to change IT supplier to gain improved service.
