- Correspondence received from the Environment Agency regarding a culvert in Larch Close where

#### 066/23/REC ITEM 12 - Quob Lane Cemetery and Burial Ground

- Several calls have been received from residents regarding the poor condition of the path in the
   Old Burial Ground TO DISUCSS & DETERMINE ACTION
- A request has been received from Reverend Maunder to remove a conifer tree within the Old Burial Ground. The arborists quote for this work is £500 – TO CONSIDER & APPROVE
- A request has been received from Reverend Maunder asking for the Grounds Team to trim the church border hedges and remove bramble in the far corner of the main church burial ground – TO DISCUSS & DETERMINE ACTION
- Councillors to agree whether to provide annual maintenance of all the hedges at St James
   Church TO CONSIDER & APPROVE
- It has been agreed that the tap at the Old Burial Ground will be removed and three water butts will be purchased. Faculty approval required. **TO NOTE**
- Following a couple of requests for more than two ashes to be placed in an ashes plot, the office staff and grounds team discussed the viability of this and determined that the limit of two ashes per plot should remain in place. Councillors to confirm whether they are in agreement with this TO NOTE
- The exhumation of Mui Yip is ongoing. The faculty has been received from the Diocese and no further paperwork is required. A specialist exhumation agency are now dealing with the repatriation. Further update to be provided by the Deputy Clerk **TO NOTE**
