# 156/24/REC Open Spaces/Recreation Areas

- The Open Spaces Risk Assessment has been reviewed TO NOTE
- A verbal update will be provided by Councillor Prince-Wright on the work being done by the Eastleigh Borough Conservation Alliance at Telegraph Woods **TO NOTE**
- There is a leak under the oak tree outside the Parish Centre which has been reported to Hampshire County Council **TO NOTE**
- Councillor Tennent was contacted by a resident that had a visit from a tree surgeon who
  informed him work was needed on an overhanging tree in his garden which backs onto Megan
  Green, as per Council instruction. No such instruction was given, and we informed the resident
  that should the Council ever need to conduct any tree work, the resident would always be
  notified in advance TO NOTE

## 157/24/REC Play Areas

- The bench in the Hatch Grange Play Area needs replacing as the wooden slats are rotten. This will be at a cost of £650.00 + VAT **TO NOTE**
- The rope swing has had to be removed again at Townhill Farm play area due to damage TO NOTE
